Concluding Reports and Remarks Superintendent's Reports/Remarks

- Mementos Superintendent Lebrun passed around some PHS mementos (1930's/1940's) that were recently donated to the District.
- Re-Opening Update Superintendent Lebrun reported that things were going very well. About 15.9% of students/parents elected to remain in remote structure. He also reported there were 2 positive COVID cases, stating, fortunately, no contact tracing was needed. There was also

reported there were some students quarantined that was related to sports (exposure from another team).

• 2021-2022 School Budget – Update - Superintendent Lebrun shared a budget showing a spending increase of 2.6%, tax levy of 2.03% (within budget the cap), an appropriated fund balance of 1.5 million and programmatically staffing as status quo. He mentioned the budget does reflect Dean of Student at Momot and a bus purchase. Superintendent Lebrun noted the budget does not reflect stimulus funds – they are still checking into the details. He stated that the Board will need to approve the budget at the next board meeting. He explained the importance of a long-range plan, hence the recommendation of a 2.03% tax levy. He asked the Board to share their thoughts on the proposed tax cap of 2.03%.

Mr. Wachtmeister, Mr. Sherman, Mr. Morris, Mr. Hall, Mrs. Goerlitz and Mrs. Boise agreed to a 2.03% tax levy. Mr. Marino and Mr. Lacey felt 1.5% was fair.

Board members asked questions regarding Medicare Part B, Bus purchases, SRO's, disbursing of Stimulus money, and Summer school. Board members thanked Superintendent Lebrun, Mrs. Zales and Mrs. LaDuke for their work on the budget committee.

Board Member Reports/Remarks

Mr. Lacey asked if the District knew how many high school students got vaccinated. Superintendent Lebrun responded no we do not.

Mr. Sherman thanked Superintendent Lebrun for sharing the mementos and thanked Oak Street School for their presentation.

Mr. Morris commented what a fantastic spotlight and thanked everyone for their efforts on the return to school.

Mrs. Goerlitz congratulated everyone on a smooth reopening.

Mr. Hall commented on the mementos and stated he hopes the district continues in the right directions. Great spotlight!

Mr. Wachtmeister commented that it was nice to see students here tonight. He referred to the experience this last year has been for our teachers. He enjoyed the mementos immensely. He asked Superintendent Lebrun if there was still a GASB45 and Superintendent Lebrun responded yes.

Mrs. Boise thanked board members who are on the budget committee and Superintendent Lebrun, Mrs. Zales and Mrs. LaDuke. She loved the history shared tonight. Mrs. Boise thanked Ms. and Mr. McGill for an exceptional job tonight. Mrs. Boise thanked everyone for here tonight and thanked the staff, students and parents for their efforts during this challenging year.

Public Comment: There were not public comments.
