

round will occur on April 8<sup>th</sup> for Oak and MOmot grades 3-5. The BRAVES pilot for our new innovative course for next year has started. We have 20 high school students participating in being trained for our first delivery of SEL from high school students to elementary students. There will be 6 days of rotations for these presentations to occur in the months of March, April and May.

- CL10 IDEA Plan this plan has been put on hold to identify how the equity work can be completed and still be in alignment with NYS and Federal regulations. School Counsel is assisting in this process.
- CL11 Create and implement learning opportunities for staff to increase awareness and knowledge regarding mental health and behavioral issues for our students Opportunities where this has been a focus include: Student SUpport Personnel monthly meetings, TCIS training, and de-escalation training. A budget proposal has been forwarded to ask for PBIS coaches to be implemented at each building to assist with behavioral/social/emotional management.
- SE8 Run participation rosters and then have student association members tap those who aren't signed up to do anything. These participation numbers for the spring will be compared to those in the winter to see if the attempted responses to increase student participation have been impactful. The responses include: highlight clubs at monthly advisory PHS, define and describe each club SMS and PHS, expand club offerings SMS. Sign-ups end on March 21<sup>St</sup> so this will be placed on the next agenda for report outs.
- SE13 Add four (4) new community partnerships with local organizations and businesses <u>and</u> Increase the number of students involved in community partnerships. No action taken
- SE14 Increase number of students involved with community partners. No action taken.
- TL5 Collaboration of professional staff opportunities to build collaborative experiences include: student writing check ins by grade level/department, early release grade level and department meetings, cross-district work sessions, PIC Superintendent's Day, coaching opportunities, New Teacher Chit Chat, reading pilot trainings and meetings, Student Support Personnel monthly meetings, Related Service Provider meetings, and Circle Train the Trainers.
