The district has implemented a fully 1:1 device program in grades PK-12 in the last 5 years. A broad, wireless network was installed as part of our first Smart Schools submission, and is planned for an upgrade as part of an upcoming E-Rate project. As such, the district has deployed an access point (AP) per classroom, and multiple APs in large meeting spaces to balance the network traffic. These APs are AC capable, providing Gigabit speeds to our mobile devices, and are connected to the Internet through an upgraded wired network (installed during the summer of 2019) with the capacity to converge these streams and carry current and future network traffic to the

This purchase would cover the 4th year of staff and student devices. The local district budget has grown in recent years with the goal of being able to fully fun the yearly fleet rotation costs. As these are replacements of existing devices, there is no anticipated change to either HVAC or electrical needs.

currently exist. The proliferation of computing devises will improve the way data from benchmark assessments is collected and analyzed. Such data plays a central role in deciding where deficiencies exist and how to improve instructional practice that best meets the diverse needs of students. The district constantly works to improve graduation rates and targets students that are at-risk of dropping out. At the secondary level, specifically, this initiative will advance the district's Academic Intervention Services (AIS) by enhancing benchmarking, providing content-specific intervention, and allowing more frequent and complete progress-monitoring. Student and teacher devises will make it possible to access interactive tools, target deficiencies, and personalize learning. Such tools have been shown to increase student academic motivation, engagement, and success. One of the goals of the Plattsburgh City School District is to provide all students with computer-assisted and highly effective instruction utilizing both subscription software and software programs such as, but not limited to, First In Math, RAZ Kids, Read Naturally, Khan Academy, EasyCBM, Breakout EDU, Quizizz, and various library databases. The district has also utilizes SchoolTool for grades and attendance monitoring and has opened this to all students and parents. Likewise, Microsoft Teams has been adopted to facilitate administration and delivery of educational course materials. Finally, the district provides all students and teachers direct access and teaching to the many tools and apps found in Microsoft Office. Some of the most astounding effects from the integration of technology in learning is that classrooms become student-centered and it becomes much easier for teachers to accommodate an array of learning styles in one setting. Students gain agency over their learning when they have access to a variety of resources. Barriers that formally prevented some students from fully participating and achieving are severely lessened if not eliminated completely. The ability for every student to have equal access to technology will also make itpossible to expand the scope of the school day and for all students to have access to school resources even after school hours. The Plattsburgh City School District has developed goals to make sure that all students are career and college ready, acquire 21st century skills, and will exhibit digital citizenship. Furthermore, Technology Integrationists have been hired to train and support teachers in how to design instruction using technology tools that are student-centered and emphasizes exploration, acquisition of knowledge, and synthesis of ideas. The district strives to create an immersive and evolving academic environment that creates future ready citizens. The technology plan that has been developed will enable this. Laptops for students and teachers can significantly enhance the learning experience for English Language Learners (ELL) compared to traditional methods. Laptops provide ELL students with access to a wide range of digital resources, such as language learning apps, online dictionaries, and educational websites. These tools can help students understand and engage with the curriculum more effectively. Digital platforms, including ones mentioned above, often include interactive elements like videos and quizzes that make learning more engaging. These interactive tools can help ELL students grasp complex concepts and retain information better. Laptops enable personalized learning experiences through adaptive learning software that adjusts to each student's proficiency level. This allows ELL students to learn at their own pace and receive targeted support where needed. Features built-in to the software utilized by teachers and students such as, speech-to-text, and text-to-speech can assist ELL students in overcoming language barriers. These tools help

students understand instructions, complete assignments, and participate in class discussions more confidently. Finally, digital platforms often provide immediate feedback on assignments and quizzes, helping ELL students understand their mistakes and learn from them quickly rather than having to wait every time to meet with a teacher one-on-one. This continuous feedback loop supports ongoing

anytime and anywhere — becomes possible for each student. The district has already invested in professional development of teachers, a District Technology Integrationists, many platforms to engage and enhance student learning. When coupled with the updated devices the district will greatly expand opportunities for student-teacher communication, student-student collaboration, and possibly, online learning opportunities. It is expected that parents will benefit from increased access to their students' work, expectations, grades, etc., when accessing ParentSquare, SchoolTool, and Microsoft Teams. With these devices, parents (via their students' devices) will have a mechanism to access content and better participate in the learning process. Teachers will be able to engage with parents and families within the purchased platform, ParentSquare. This program allows schools to send messages, announcements, and reminders directly to parents through various channels, including email, text, and the ParentSquare app. This ensures that parents stay informed about school events, important dates, and their child's progress, fostering greater involvement in their child's education. Parents can customize their communication preferences in ways that work best for their family. In addition, ParentSquare is designed to be a secure way to message. It uses encryption and other security measures to protect the privacy and confidentiality of communications between schools and families. This ensures that sensitive information, such as student data and personal details, is kept safe from unauthorized access. Distance learning opportunities are expanding rapidly, the district currently utilizes Edgenuity/as well as Champlain Valley Educational Services' (of the CEWW BOCES) impressive slate of online curricular offerings.

Firstly, they have access to coaching opportunities, monthly professional development, and tools like the Bookings app. These supports help create a robust environment where teachers can confidently use technology to enhance their teaching and improve student learning outcomes.

Secondly, the District Technology Integrationist provides coaching through one-on-one or small group sessions to help teachers integrate technology effectively into their lessons. All second-year teachers at PCSD go through a coaching cycle, which is available to all teachers. The district technology integrationist can demonstrate how to use specific tools, such as interactive whiteboards or engaging software, within the classroom itself.

Additionally, the District Technology Integrationist provides overarching support and resources, ensuring consistency across the district. Each building's integrationist point person offers immediate, on-site support, helping teachers troubleshoot issues and integrate technology effectively.

Furthermore, the Microsoft Bookings app allows teachers to easily schedule co-teaching sessions, ensuring they can collaborate with the district technology integrationist. Teachers can book time with specific tools, applications, or resources to enhance their lessons.

Moreover, training is provided to utilize the ViewSonic Panels purchased for every classroom in the district. Teachers can create engaging, interactive lessons using the ViewSonic Panel, which supports multimedia content and interactive activities. Ongoing training
